As a nationally accredited land trust, we've adopted and are required to follow land trust standards and practices, which means we must monitor our conservation easement properties annually. We also have policies on easement violations and enforcement. Our enforcement policy includes stipulations for annual monitoring, identification of a possible violation during the monitoring visit and the steps to be taken to confirm and resolve any violation.

Easements: The Conservancy receives or purchases conservation easements from various landowners and it is recorded as an expense for conservation restrictions, a component of program services, in the statement of activities in the year of its purchase. Easements are legal restrictions that permanently protect land while leaving it in private ownership. A landowner donates or sells the easement to the Conservancy, which in turn ensures that the conditions of the easement are met over time. While the owner still retains the fee interest in the land, it is the Conservancy's responsibility to monitor compliance with restrictions as set forth in the easement and to take action, including legal measures if necessary, to correct any violations.

The endowment funds are for conservation purposes and the investment earnings are intended to be used to maintain, monitor, and for the enforcement of conservation easements.
